In pursuance of the provisions of Rule 48 of the Electricity Rules, 1937, the Governor of N.W.F.P. is pleased to direct that in Conditions prescribed in the Electricity Department Notification No.893, dated 1.2.1940 for the grant of Certificate of Competency to Electrical Workmen and Licenses to Electrical Contractors, the following amendment shall be made namely:-

AMENDMENT.

1. For Condition, 2 the following condition shall be substituted namely;

"2-Constitution of the Board:

3. Terms of the Appointment.

The terms of appointment of Members shall be two years.

6. The Board shall ordinarily meet after every three months for transaction of all business mentioned in Rule 5, above.

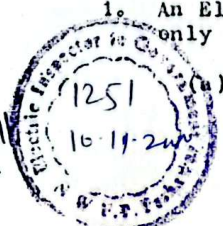
For item (1) under Chapter III the following shall be substituted namely,

1. An Electrical Contractor's License shall be granted only to a person or a firm if such person or firm, holds a certificate of competency and personally executes or supervises all

work undertaken by him or it or has employed an Electrical Supervisor holding a certificate of competency granted by the N.W.F.P. Government under whose supervision such work is carried out.

- (b) is in possession of the testing instruments enumerated in Schedule-I.
- (c) maintains separate, independent suitable premises in a conspicuous place to the satisfaction of the President of the Board.

Note:- If at any time the licensed Electrical Contractor fails to observe the conditions (a to c) above, his license shall be liable for suspension by the President of the Board.

SCHEDULE-I.

The following shall be substituted in Schedule-I namely:-

Each Electrical Contractor will be required to possess the following instruments:-

CLASS 'A' CONTRACTOR.

- (1) One Insulation tester (Megger) 500 volts variable pressure, 20 Megaohms with the name engraved of the contractor.
- (2) AVO Meter:- variable pressure 500 volts-100 Amps. (with the name engraved of the contractor) Class 'E' Contractor (For all Classes).
- (3) One Earth Resistance Tester with range upto 10 ohms. (with the name engraved of the contractor).

Note:- The Board shall be competent to relax for a specified period the Condition of having any testing instruments, which are not readily available in the market.
